To medical/health practitioners or staff, or those dealing directly/indirectly with vaccines,

We, and countless millions worldwide, have serious concerns regarding the safety of the Covid vaccines, as do many thousands of highly qualified doctors, nurses, health professionals, and scientists.

From 9 Dec 2020 to 9 Feb 2022, 1,458,428 suspected UK adverse drug reactions (ADRs) were reported by 445,256 people in the context of Covid vaccines, within the "Yellow Card" reporting system. 2,017 deaths were reported. Yellow Card reports don't prove the vaccine was the cause, however it's possible a significant or high percentage of the ADRs and deaths were caused by the vaccine.

It's estimated only 10% of serious ADRs are reported. If we assume 7% of the 1,458,428 suspected ADRs were "serious", that is 102,089 serious ADRs. Adjusting for underreporting, that becomes 1,020,890 serious ADRs.

Several "time vs death rate" charts indicate strong correlation between start of vaccine rollout and increased death rates. The correlation doesn't prove the vaccines are the cause, however they may be. The correlation adds another data point to a growing list.

It is shocking, and cynical, that life-changing vaccine injuries experienced by many have attracted no media coverage whatsoever. This is corrupt beyond measure, and should be of deep concern to all.

A crime was reported with Hammersmith Metropolitan Police CID, relating to the Covid vaccines. Over 400 statements, several from GPs, and many from those whose health has been impacted or severely impacted, were submitted. Some of the statements are from families of the deceased. The evidence includes testimony from NHS and care home whistleblowers, over 1000 scientific studies, and testimony of many renowned scientific/medical practitioners. Two independent forensic reports exposing harmful ingredients, eg graphene and glass shards, were submitted. Although there appears to be resistance from the police to becoming involved, they cannot simply refuse to examine a large body of credible evidence if they are undertaking their duties and acting according to their oath, so ignoring the evidence may suggest malfeasance and/or dereliction of duty.

On 22 Oct 2020, Steve Anderson gave a presentation which included this draft list of possible adverse events : Guillain-Barré syndrome, Acute disseminated encephalomyelitis, Transverse myelitis, Encephalitis / myelitis / encephalomyelitis / meningoencephalitis / meningitis / encephalopathy, Convulsions / seizures, Stroke, Narcolepsy and cataplexy, Anaphylaxis, Acute myocardial infarction, Myocarditis / pericarditis, Autoimmune disease, Deaths, Pregnancy and birth outcomes, Other acute demyelinating diseases, Non-anaphylactic allergic reactions, Thrombocytopenia, Disseminated intravascular coagulation, Venous thromboembolism, Arthritis and arthralgia/joint pain, Kawasaki disease, Multisystem Inflammatory Syndrome in Children, Vaccine enhanced disease.

It's questionable how a vaccine with that list was approved. However, that list wasn't included on Pfizer fact sheets, or discussed with people receiving the vaccine. More complete fact sheets were released in Jan 2022.

We urge all people to take personal responsibility for their actions. We have a collective duty to know whether the orders we follow truly represent the interests of the public. Following orders without question has been responsible for some of the worst atrocities observed in history. If our civilised society and education system has one benefit, it should be the ability to look to past mistakes, and avoid repeating them.

A key principle of the UNESCO Universal Declaration of Bioethics and Human Rights 2005 is Article 6, covering "informed consent", meaning the person concerned must be given adequate information that they understand. Growing evidence of the risk of adverse events or death suggests that this principle is not being adhered to, which has crime implications. The issues mentioned with the Pfizer fact sheets further affect informed consent, as does the lack of explaining therapeutics and alternative treatments.

Substantial and steadily growing evidence points towards the SARS-CoV-2 vaccines causing harm. We urge all parties to cease administering the vaccines. People who continue to administer the vaccines, or directly/indirectly facilitate the continuing administering of the vaccines, could potentially be found guilty of one or more crimes.

People underestimating the seriousness of the events unfolding may be surprised when the full extent of what has taken place during Covid gradually becomes known. We urge people to practice critical thinking, and question whether the many "fact check" pages might be driven by motives/interests that are not aligned with the greater public good. The same applies to the many social media influences that seek to discredit those highlighting the harm that has resulted from the vaccines.

In addition to the legal implications, we hope people have a sense of moral obligation to act in ways that put the interest of the public first. We believe that doing so necessitates the cessation of the Covid vaccine program.
