

Dear Pharmacist and Pharmacy Staff,

Re: Administration of Covid-19 Experimental Injections

I need to ensure you are aware of a very serious situation in regards to the roll out of the Covid-19 injections, both in terms of their lack of efficacy but also much more importantly in terms of the huge numbers of deaths and serious injuries being reported due to these injections.

I believe you have been involved in promoting or even administering these injections to members of the public. I need to make you aware of the following:

FULLY INFORMED CONSENT IS NEEDED IN ORDER TO REDUCE THE RISK OF PERSONAL LIABILITY TO YOU AS A RESULT OF ANY HARM OR INJURY CAUSED BY A COVID-19 INJECTION

Manufacturers have been granted exemption from liability but there is still the potential for claims for injury or death resulting from Covid-19 injections against the individuals administering or promoting these injections. Successful claims are likely to rest on whether the person administering or promoting the injections was aware of the potential adverse reactions.

The facts below are not an exhaustive list of the areas that I hope are being considered by you in obtaining fully informed consent. Further information is also provided in regards to consent in the links below. A review of these and other points need to be documented as part of your process of obtaining fully informed consent:

- Most importantly, people must be made aware that they are part of an experiment, the injections are still in Phase 3 clinical trials and have not received full approval; the trials have been short and there is no long term safety data.
- People need to know that these are not standard vaccines and are instead gene based therapies that have never been used in this way before.
- Manufacturers' claims of effectiveness of the injections are based on evidence of effectiveness in preventing mild symptoms; the trials did not consider severe disease, hospitalisation or even death.
- Many population cohorts were not included; likewise much of the evidence on the impact on children, pregnant women and others is taking place in real time. The impact of combining the injection with other medications is still unknown. It will be years, perhaps generations, before the full impact of these gene based injections is known.

- Overall the Covid Mortality rate is around 0.2% of the UK population over the last almost two years. Those included as dying **WITH** Covid-19 were noted as “having died for any reason within 28 days of a positive Covid-19, test”; most were very elderly and overwhelmingly suffering with multiple existing health issues.
- The tests diagnosing Covid-19 are known to be extraordinarily inaccurate; generating up to 97% false positives.
- The risk is extremely low in younger populations and lower still in children. Are people being made aware of their **low** risk of serious disease or death from Covid-19 before being injected?
- A Lancet study, has called out that the injection manufacturers were using Relative Risk Reduction (up to around 95%) rather than Absolute Risk Reduction (ARR) in promoting these vaccines. The ARR is the correct measure to be shared, as agreed by peer reviewed science over many years The ARR of these injections was shown to be around **just 1%**.

- Many safe and effective treatments already exist including Ivermectin, Vitamin D, Vitamin C and Zinc. Are you sharing information about effective / safe treatments for viral infections including for SARS-CoV-2?

HIGH NUMBERS OF DEATHS AND INJURIES REPORTED TO MHRA, EMA AND CDC FOLLOWING THE COVID-19 INJECTIONS (THIS INCLUDES CHILDREN, PREGNANT WOMEN AND UNBORN BABIES):

- **In the UK a total of 2,040 deaths are now reported by MHRA Yellow Card Scheme along with almost 1.5 million injuries suffered by almost 448,000 people** (an average of 3.3 injuries per person). We know the MHRA themselves believe that reported cases are only 1%-10% of the true harm being done. Very many of these issues are serious, life threatening and permanently life changing events. Across the EU and USA and elsewhere the picture is just as horrifying:

- **EU to 12th February 2022 – 39,997 Covid-19 injection-related deaths and over 3.6 million injuries, reported by over 1.5 million people** per the EMA EudraVigilance Database. Link to the database: https://www.adrreports.eu/en/search_subst.html#/

- **USA to 4th February 2022– 23,615 Covid-19 injection related deaths and over 5.3 million injuries reported by over 1.1 million people** – Per the CDC VAERS database. Link: <https://openvaers.com/covid-data> or directly <https://medalerts.org/vaersdb/index.php>

In addition, the MHRA (see details in the MHRA weekly report on the link above) are also reporting (Feb 2022) that:

- **3,487 children have now reported injury, harm or death** following a Covid-19 injection.
- The MHRA has disclosed that **61 children are now suffering with myocarditis, pericarditis or related** following the Covid-19 injections.
- Most other details of the deaths of children and the number of injuries being suffered by children have not yet been disclosed by the MHRA.

There are almost 9 pages of known side-effects from the Pfizer Covid-19 injections including:

- **Pericarditis** (page 31 of the Pfizer document)
- **Convulsions in childhood** (page 32 of the Pfizer document)
- **Myocarditis** (page 35 of the Pfizer document)
- **Multisystem inflammatory syndrome in children** (page 35 of the Pfizer document) – The MHRA is now reporting on four cases of this issue in children following the Pfizer injection.
- **Sudden unexplained death** (page 37 of the Pfizer document)

It is critical that you are providing people with all the information necessary for them to assess both their risks from Covid-19 and their risks from these experimental injections. You can play a vital role in warning people of the damage from further injections and indeed warning people, especially the parents of young children, of the potential risks they are taking with their own and their child's health from these injections.
